Treasurer's Report



It is my honour to present the Treasurer's Report for the Sri Lanka Library Association (SLLA) for the financial year 2024/2025. This report outlines the Association's current financial position, key challenges we face, and recommended actions to ensure long-term sustainability and resilience.

1. Financial Overview

Unfortunately, the Association has incurred a financial deficit this year. We have not been able to generate a surplus, and our expenditures have exceeded our income. The only consistent source of income has been the interest earned from our fixed deposits an income stream that is becoming increasingly unsustainable due to falling interest rates and rising inflation.

Primary Contributing Factors

Decline in Student Enrolment: Competition from universities and other institutions offering Library and Information Science (LIS) programmes has led to reduced enrolments in our own educational offerings.

- Low Membership Fees: Our current membership fee structure is among the lowest compared to other professional bodies, and it is insufficient to meet operational costs:
 - Fellow Members: Rs. 4,000
 - Corporate Members: Rs. 2,500
 - Non-Corporate Members: Rs. 2,000

2. Key Expenditures

- Staff Salaries and Statutory Compliance: These remain our largest financial obligations.
- Utilities and Administration: Monthly electricity, water, telephone, and office maintenance costs are substantial.
- Recurring Operational Costs: The Association requires an average of Rs. 300,000–400,000 per month (approximately Rs. 4 million annually) for basic operations, including honoraria for lecturers and costs associated with our educational programmes.

3. Loss-Making Activities

Several flagship activities are generating losses due to lack of cost-recovery mechanisms:

- Annual General Meeting (AGM): Funded entirely by membership fees, with no participation charges. Additional costs for providing complimentary meals and snacks exacerbate the financial burden.
- Annual Conference: No structured budgeting or revenue strategy has led to recurring losses.
- Award Ceremony: Insufficient planning and lack of participant fees have made this another loss-incurring event.

4. Declining Income Sources

- While our educational programmes still generate some revenue, it is declining steadily. Any small surplus is typically used for daily operations rather than reinvested.
- Over the past three years, no new contributions have been made to our fixed deposit accounts.
- We are increasingly reliant on interest income, a dangerous trend that places the Association's future at risk.

5. Recommendations for Financial Sustainability

To address the financial challenges and protect the future of the Association, I propose the following remedial measures:

a. Introduce Participation Fees

- Introduce a nominal fee for AGM participation, in addition to membership dues.

b. Increase Conference and Event Fees

- Implement a tiered increase in conference and event registration fees to better align with actual costs.

c. Budgeting and Cost Recovery

- Prepare detailed budgets for all major events (*i.e* Award Ceremony) and ensure adequate participant contributions.

d. Expand Revenue-Generating Programmes:

- Increase the frequency and scale of workshops, seminars, and Continuing Professional Development (CPD) programmes.
- Encourage committees to develop financially self-sustaining or profit-generating initiatives, supported by sponsorship where possible.

e. Review Educational Programme Fees:

- Conduct a market analysis and revise course fees to reflect current standards and demand.

f. Review Life Membership Policy:

- Currently, life members receive free membership after 20 years. Introduce a nominal renewal fee every five years to sustain income from this member segment.

g. Seek Sponsorships and Partnerships

- Actively pursue institutional and corporate sponsorships for key events and programmes.
- Explore cost-sharing partnerships with relevant organizations.

h. Establish a Financial Planning and Audit Sub-Committee

- Create a dedicated sub-committee to oversee financial planning, monitor budgets, and guide long-term financial strategies.

i. Digitize Administrative Functions

- Invest in automation and digital tools to reduce recurring operating expenses.

6. Appreciation and Way Forward

I wish to extend my sincere appreciation to the committees and individuals who successfully organized events through sponsorships or in-kind contributions. Their dedication and resourcefulness have added significant value despite the financial constraints.

In conclusion, if immediate corrective actions are not taken, the Association risks depleting its interest income, ultimately eroding its fixed capital. Such a situation could lead to a financial crisis that jeopardizes the continued existence of the SLLA.

This Association belongs to its members. We must work together, as custodians of this profession, to restore financial stability and ensure that the SLLA remains a vibrant, effective, and sustainable institution.

1.1 Council and Ex-Co Meetings

The council of the SLLA conducted nine (09) regular meetings, including three special meetings in the year 2024/2025, and five (05) Executive Committee meetings were conducted. Most of these meetings were held both physically and online.

2. SLLA Membership 2024/2025

SLLA members are divided into two main categories: Non-corporate and Corporate. Corporate members, which include associate and fellow members, have full membership rights, including voting power. Non-corporate members do not have voting power. They can upgrade their membership to corporate members after having adequate experience in the profession. The total membership of the SLLA is 1249 as of 26th June 2025.

The Institutional membership category of the Sri Lanka Library Association (SLLA) was established to provide institutions with enhanced opportunities, access to professional resources, and collaborative potential within the library and information services community. Introduced under the SLLA bylaws and aligned with the SLLA (Incorporation) Law No. 20 of 1974 and amendment Act No. 7 of 2004, this membership category enables institutions to actively participate in the development and promotion of library and information services across Sri Lanka.

2.1 Non-corporate Membership

The non-corporate new membership is eighty (80)

2.2 Associate Membership

SLLA received thirty (30) applications. Out of them, the associateship was awarded to twenty (20) members for the year 2024/2025.

2.3 Fellowship Awardees

SLLA received four (04) applications, and no one was eligible for the fellowship 2024/2025. The total number of fellow members of SLLA remains at sixty-five (65).

2.4 Chartered Membership

Associates and fellows get chartered librarianship for a given year if their membership is active. There are four hundred and six (406) members in the chartered list for the year 2024/2025.

2.5 Life Membership

Long-standing SLLA members can apply for life membership of SLLA. Life membership was newly awarded to five (05) members for the year 2024/2025. This brings the total number of life members to two hundred and forty-one (241).

2.6 Institutional Membership

Institutional membership 2024/2025 offered to Swami Vivekananda Cultural Centre and National Science Foundation. The total institutional membership of the SLLA is two (02) as of 26th June 2025.

2.7 Vijita de Silva Research Award (VDSRA)

SLLA received three (03) applications, and no one was eligible for the Vijita de Silva Research Award for the year 2024/2025.

4. SLLA Education Programme

In the year 2025, the Sri Lanka Library Association (SLLA) marks a significant milestone, celebrating 65 years of excellence in Library and Information Science (LIS) education. Throughout its history, the SLLA has conducted two major professional educational programmes: the Diploma in Library and Information Science (DLIS) and the Higher Diploma in Library and Information Science (HDIPLIS). The HDIPLIS programme comprises two academic years, namely HDIPLIS I and HDIPLIS II. These programmes are delivered in Sinhala, Tamil, and English mediums, primarily through an online learning platform. Students from all regional centers, Colombo, Kandy, Galle, Badulla, Jaffna, and Batticaloa are enrolled and participate in these courses via online mode. In addition, the Distance Education Programme (postal) is conducted in Sinhala medium for students who prefer distance learning modalities.

During the 2024-2025 academic year, several amendments have been made to the existing By-Laws governing these programmes. These revisions include updates to the procedures for releasing examination results, the submission of indexes and bibliographies, and significant

changes to the research project component. Notably, the research project, initially introduced as a pilot in the 2023-2024 academic year, has been made a compulsory component for all students commencing from the 2024/2025 academic year. Furthermore, a Distance Education Programme continues to be offered for students who are unable to attend regular lectures. Under this programme, all required course materials are dispatched to the students via postal service, enabling them to pursue their studies independently. The following courses were conducted by the SLLA in the academic year 2024/2025.

4.6 Certificate Course on Library Automation (COLA)

The Certificate Course on Library Automation (COLA) is one of the well-recognized programme conducted by the SLLA. The primary objective of the course is to enhance the skills and competencies of librarians in utilizing information and communication technologies (ICT) for effective information dissemination and retrieval. The course, which has a duration of nine months, provides comprehensive training in key areas of library automation, including: Introduction to Information Communication Technology (ICT), Introduction to Library Automation, Library Automation using the Koha Integrated Library Management System, Electronic Library Resources and Services, and Web Designing, Hosting, and Maintenance. This programme continues to play a significant role in equipping library professionals with the technical knowledge required to meet the evolving demands of modern library services.

The Inauguration Ceremony of the Certificate Course on Library Automation took place at the Colombo Public Library on 28th September 2024, with the participation of council members, the COLA lecture panel, and students. Mr. M.N. Ravikumar, Ms. R.M. Nadeeka Rathnabahu, Ms. Hiruni Kanchana, and Ms. Muditha Ankumbura were the lecturers on the COLA course. Ms. Muditha Ankumbura was the coordinator for the 2024/2025 year. The classes were commenced on 12th October 2024, and 20 students successfully completed the course and qualified to receive the certificate of completion.

4.7 Examination Board

The Examination Board (EB) for the academic year 2024/2025 was appointed by the council to support the education committee in maintaining the integrity, fairness, and transparency of the examination process, ensuring that no student is subjected to discrimination. The Board was chaired by Dr. (Ms.) C.K. Gamage, Education Officer, with Dr. G. R. Padmasiri, Librarian at the University of Visual and Performing Arts, and Dr. (Ms.) T. Sritharan, Senior Assistant Librarian at the University of Colombo, serves as members of the board.

During the academic year 2024/2025, the examination board convened on three occasions, 28th August 2024, 25th March 2025, and 25th May 2025. These meetings were held to review and approve the results of the examinations conducted for the HDIPLIS I (2023/2024), HDIPLIS II (2023/2024), and DLIS (2023/2024) programmes.

4.8 Education Committee

2024, the Education Committee is comprised of several members and is chaired by the Education Officer, Dr. (Ms.) C.K. Gamage. Ms. Kaushalya Rathnasekara, Assistant Education Officer, together with the Centre Coordinators, Teaching Faculty, and the SLLA Office Staff, collectively contributed to the development and continuous enhancement of the educational programmes. During the academic year 2024/2025, the Education Committee convened six meetings. Throughout the year, the committee accomplished several key initiatives aimed at improving the quality and effectiveness of the education programmes.

4.9 Activities and Achievements of the Education Committee - Academic Year 2024/2025

The key activities and achievements of the committee during this period are as follows:

4.9.1 Revision of Course and Items Fees

The fee structure applicable to the academic programmes was reviewed and revised to ensure alignment with current academic and administrative requirements. The revision covered various components, including course fees, examination fees, re-correction fees, certificate awarding fees, and other related charges.

4.9.2 Establishment of a Research Pool

A research pool comprising suitably qualified lecturers currently affiliated with the SLLA lecturer panel was established to strengthen and in alignment with the HDIPLIS II Research Project. This initiative is intended to strengthen the academic and research components of the SLLA's educational programmes. Eligibility criteria for inclusion in the research pool require candidates to be: (i) currently serving as a visiting lecturer of the SLLA; (ii) holders of a postgraduate degree that includes both course work and a research component; and (iii) Associate Members of the SLLA.

4.9.3 Indexing/Bibliography Workshop and Development of a Guideline -HDIPLIS I

A workshop was conducted in 4th May 2025 by Dr. (Ms.) T. Sritharan and Mr. K.K.G. Wijeweera for all indexing lecturers, supervisors, and examiners. The workshop was held in a bilingual format with the objective of addressing the differing views among supervisors and examiners, as well as the lack of clear understanding among students in the preparation of indexes. As an outcome of the workshop, an *Indexing Guideline* was developed. It was decided that necessary actions will be taken to print and circulate the guideline among HDIPLIS I students.

4.9.4 Cataloguing Workshop and Development of Guideline

A workshop for lecturers teaching cataloguing in the DLIS and HDIPLIS I programmes was conducted on 10th May 2025. The primary objective of the workshop was to establish a uniform method of cataloguing based on AACR2 and to address related concerns. Mr. Sugath Gunathilake and Ms. Kaushalya Rathnasekara conducted the workshop in English and Sinhala, while Mr. B. Prashanthan contributed by sharing his knowledge in Tamil. As an outcome of the workshop, a *Cataloguing Guideline* was developed, which will be printed and circulated among DLIS and HDIPLIS I students.

4.9.5 Development of a Guideline for Thesaurus Construction

It was identified that a guideline for Thesaurus construction is a compulsory requirement for the HDIPLIS II students. Accordingly, Mr. M.N. Ravikumar was assigned to develop the guidelines.

4.9.6 Syllabus Revision Workshop

The Education Committee decided that the existing syllabi of the HDIPLIS I and HDIPLIS II programmes required revision. As the initial step in the syllabus revision process, a workshop for the lecturers was held on 22nd February at the Bambalapitiya Vajiraramaya. The workshop featured contributions from Senior Prof. W.A. Weerasooriya, University of Kelaniya, Senior Lecturer (retired) Mr. T.G. Pemadasa, NILIS and Senior Lecturer, R.M. Nadeeka Rarhnabahu, University of Kelaniya, who shared their expertise and actively engaged in the discussions on syllabus revision. Subsequently, the lecturers involved in teaching the respective modules submitted their suggestions for revisions. The syllabus revision process is currently ongoing.

4.10 Evaluation of SLLA Courses through Student Feedback

In order to evaluate the effectiveness of the courses conducted by SLLA, three separate questionnaires were distributed among the students who followed the DLIS, HDIPLIS I, and HDIPLIS II programmes in Sinhala, English, and Tamil mediums. Collecting feedback directly from students, as the primary stakeholders, is considered one of the most effective methods for course evaluation. The questionnaires focused on key aspects such as course content, teaching panel, teaching and learning process, and invited suggestions for future improvements.

4.11 Committees Appointed in Academic Year 2024/2025

4.11.1 Curriculum Development Committee – Course on Library Technician

The Education Committee decided to reintroduce the “Library Technician” course, a six-month programme designed for library workers with basic educational qualifications.

A committee comprising nine members namely Prof. Ruwan Gamage (Chairperson), Dr. R.D. Ananda Tissa, Dr. (Ms.) M.M. Mashroofa, Dr. (Ms.) C.K. Gamage, Ms. Sakunthala Senevirathne (Secretary), Ms. Thivya Janen, Mr. Sugath Gunathilake, Mr. Chamal Abeygunawardhane, and Ms. Kaushalya Rathnasekara was appointed to develop the curriculum.

4.11.2 Committee on Tamil Translators

The Education Committee appointed a panel of Tamil translators, comprising Mr. M. N. Ravikumar, Mr. Santharooban, Dr.(Ms.) T. Sritharan, Dr. Shanmugadasan, Ms. Komathy Murugathas, Ms. Thivya Janen, Mr. B. Prashanthan, Mr. Rodney Fernando, Mr. Siyath Ahamed, Mr. M.S.M. Shiham, and Ms. Loshyni Vignashwaran, to support educational activities and ensure the credibility availability of course materials in Tamil medium.

4.12 TVEC Registration

6.2 Information and Public Relations Committee (IPRO)

List of the newly appointed SLLA council members for 2024/2025 term was published in the 'Daily News' paper on Saturday, 7th September 2024, ensuring transparency and public awareness of the leadership of SLLA.

An orientation programme for the SLLA council members was successfully held on 29th November 2024 at the SLLA auditorium. The session, conducted by Immediate Past President (IPP) Dr. R. D. Ananda Tissa, aimed to enhance members' understanding of the history of SLLA and to provide an overview of the various services offered by the association. Additionally, it clearly defined the expectations and responsibilities of the conveners.

Flyers and notices, including those related to membership renewal and obituary announcements, were designed and disseminated. The Sustainable Development Goals (SDG) group of the Sri Lanka Library Association successfully conducted a virtual lecture titled “Emerging Trends in Library Management” on 30th March 2025 at 8.30 p.m., as part of its ongoing efforts to promote the integration of sustainable development principles into library and information services in Sri Lanka. The session, held via Zoom, featured Dr. Elavazhagan Kannan, Chief Librarian of the Indian Institute of Management (IIM), Tiruchirappalli, India, as the keynote speaker. The session was moderated by Ms. Dilhani Munasinghe.


2nd Webinar - Collaborative Discussion on Sustainable Energy Consumption in Library Premises

The SDG group of the Sri Lanka Library Association in collaboration with the Sustainable Development Council, successfully conducted a focused discussion on the theme “Sustainable Energy Consumption in Library Premises” (ප්‍රසන්නකාල පරිශ්‍රයන් තුළ තිරසර බලශක්ති පරිභෝජනය) on 22nd April 2025, at 8.30 p.m. The session provided a valuable platform for knowledge exchange among LIS professionals, sustainability experts, and key institutional stakeholders. It addressed the best practices, challenges, and strategic approaches for enhancing energy efficiency within library environments. This collaborative initiative significantly contributed to the ongoing efforts of aligning library operations with national and global sustainability goals, particularly in the areas of climate action and responsible energy consumption.

6.5 Special Libraries Group

Over the past year, the Special Library Group of the Sri Lanka Library Association (2024/2025) has accomplished a significant number of activities through the collective efforts and dedication of its members. Through strong teamwork and commitment, the group successfully organized and completed many initiatives, contributing actively to the development and promotion of special libraries in Sri Lanka. The work over the past year stands as a testament to their enthusiasm, professionalism, and shared vision for strengthening the library profession.

The following programmes and tasks conducted by the group.

- A WhatsApp group was launched to share ideas, exchange information, and foster collaboration among librarians. With nearly 51 members already joined, it has become an active platform for professional networking and support.
- A distinctive and vibrant logo was created to represent and unite the members of the group. It was collaboratively designed by Ms. Manoha Prasadi, Ms. Arosha Wasala, and Ms. Vishaka Narmada, reflecting the group's spirit and identity. 
- A Zoom programme was conducted on 26th October 2024 by the Special Library Group, featuring a session on the Central Environment Authority. The theme of the session was (ලොවටම දැනුම බෙදන ජාතික පාරිසරික තොරතුරු මධ්‍යස්ථානය). The resource person was Ms. T.M.C. Hansamali Tennakoon, Librarian at the Central Environment Authority. A total of 31 participants attended the session. Ms. Vishaka Narmada introduced the resource person, while the vote of thanks was delivered by Mr. Dhaminda Manamperi.
- On 12th October 2024, the Special Library Group visited the Law & Society Trust Library at Kynsey Terrace, Colombo 08. The group received a warm welcome from Librarian Ms. Arosha Wasala, who provided an informative introduction to the library. Following the introduction, a discussion was held on strategies to enhance library services within a multi-disciplinary institutional setting.
- A Zoom programme was organized on 30th October 2024 on the topic (නීතිය අනුගමනය කිරීම සහ දැනුවත්ව සිටීම සුරක්ෂිත වෘත්තීය ජීවිතයකට මග) (Following the Law and Staying Informed: Key to a Secure Professional Life). The session was conducted by Mr. Vidura Munasinghe, a Senior Researcher, Activist, Translator, and Lawyer at the Law & Society Trust, with 43 participants in attendance. The programme was opened by Ms. Arosha Wasala, and the resource person was introduced by Ms. Priyadarshani Hemakumara. Mr. Munasinghe emphasized the importance of complying with legal frameworks in the workplace, maintaining professionalism, and effectively managing others through proper rules and regulations.

The session was highly interactive, with active participation and insightful guidance provided throughout.

- A one-day physical workshop on the Universal Decimal Classification (UDC) system was organized for librarians on 10th December 2024 at the Colombo Public Library, Colombo 07. The resource person for the workshop was Mr. Dhammika Rathnayaka, Senior Assistant Librarian at the University of Kelaniya. A total of 27 librarians participated in the workshop, which commenced at 8.30 a.m. and concluded at 1.30 p.m. Refreshments and certificates were provided to all attendees. A participation fee of Rs. 1,500.00 per person was charged. The workshop was primarily practical in nature, offering an engaging and hands-on learning experience. Mr. Rathnayaka delivered insightful training on the UDC system, which was highly appreciated by the participants.
- The J.R. Jayewardene Centre, in collaboration with the SLLA Special Library Group, organized a physical workshop on document preservation on 13th December 2024 at the J.R. Jayewardene Centre Auditorium. The workshop was held under the theme “Challenges and Solutions for Preservation Faced by Library Directors.” Dr. Udaya Cabral, Director of the National Library and Documentation Services Board, served as the main resource person, while Mr. Nuwan Chandradasa, Assistant Preservation Officer at the J.R. Jayewardene Centre, conducted the practical sessions. A total of 40 participants attended the workshop, which covered key topics such as document preservation techniques, digitization, environmental control, and hands-on preservation methods. The event was coordinated by Ms. Ashani De Alwis, Librarian at the J.R. Jayewardene Centre.
- The Special Library Group organized a library tour to the J.R. Jayewardene Centre Library and Museum, where Librarian Ms. Ashani De Alwis conducted a guided tour. Nearly 25 librarians participated, gaining valuable insights into promoting special libraries and their services to the public.
- The SLLA Special Library Group voluntarily participated in the reorganization of the library at the National Cinnamon Research and Training Center, Department of Cinnamon Development, Palopitiya, Thihagoda, on the 18th and 19th of January 2025. The team successfully completed several key tasks, including library design, accessioning, cataloguing, classification, automation, labeling, and staff training. The initiative was coordinated by Ms. Manoha Prasadi. Automation tasks were managed by Mr. M. Fahir, while classification work was carried out by Mr. Aruna Dinesh Gunarathna. Mr. Dhaminda Manamperi and Mr. Vajira Prasad also made valuable contributions to the successful completion of the project.

6.6 Academic Libraries Group

The Academic Library Group of the Sri Lanka Library Association successfully conducted a Workshop, a Short Course, and four Webinar Series via the physical and Zoom platforms. Details as follows;

6.6.1 Training Programme for Librarians of Sri Lankan Pirivenas

Focusing on “Effective Library Management and Collection Development”, the training programme was successfully conducted on 7th November 2024, organized by the Academic Library Group of the Sri Lanka Library Association in collaboration with the Library of Bhiksu University Sri Lanka, Anuradhapura and Pirivena Division of the Ministry of Education. The event was held at the auditorium of the Faculty of Languages and Cultural Studies, Bhiksu University of Sri Lanka.

A total of 105 librarians from Piriven institutions participated, representing the districts of Anuradhapura, Polonnaruwa, Trincomalee, Vavuniya, and Mullaitivu. This initiative marked a significant step in enhancing the professional competencies of Piriven librarians and strengthening library systems across the country. 6.6.2 Short Course on “Mastering Research: A Guide to Your Research Journey”

The Academic Library Group successfully organised a short course titled “Mastering Research: A Guide to Your Research Journey”. The course was aimed at equipping participants with essential research skills and was conducted in both Sinhala and Tamil medium.

6.7 ICLIS & LIS Research Committee

The Research Committee of SLLA conducted the International Conference on Library & Information Science (ICLIS-2025) in collaboration with the Library Network of the University of Peradeniya at the Diamond Jubilee Conference Hall, Faculty of Agriculture, University of Peradeniya, Sri Lanka on 26th June 2025. ICLIS-2025 served as a global platform for researchers, academics, library professionals, and information specialists to exchange knowledge, explore emerging trends, and discuss innovations in Library and Information Science (LIS). Themed “Libraries as Pillars of Sustainable Socio-Cultural Capital,” the conference focused on critical areas.

6.8 Committee on Monitoring and Assigning in the Implementation of Strategic Plan (COMAISP)

The Strategic Plan of the Sri Lanka Library Association (SLLA) for the period 2016–2022 was originally formulated by the Strategic Planning and Strategic Directions Committee (SPSDC). Due to the pending implementation of many strategic actions, the current SLLA council has extended the validity of this strategic plan for an additional five years, until 2027. The council appointed Ms. Thivya Janen as the convener of the Committee on Monitoring and Assigning in the Implementation of the Strategic Plan (COMAISP). During the year, COMAISP focused on two ongoing projects. Additionally, the committee submitted a proposal to conduct a

brainstorming session on the strategic plan, intended for newly appointed council members, committee conveners, and committee members. However, due to time constraints, the session could not be held. Three new projects have been identified, pending council approval. The details are as follows:

6.9 Public Libraries Group

- A Zoom session organized by the Public Library Group was held on 24th January 2025 at 8.00 p.m. on the topic “The Role of Public Libraries in Social Development.” The session was attended by 65 library professionals and Dr. R. D. Ananda Tissa, former President of the Sri Lanka Library Association, as the resource person. The session contributed significantly to enhancing the quality of services provided by public libraries and helped address several professional challenges faced by public library staff.
- A one-day workshop on “Koha Technical Issues and Stock Taking” was held on 7th February 2025 at the Kurunegala Public Library. The resource person for the session was Ven. Paluwakande Seewali Thero from the University of Kelaniya. A total of 60 public librarians from libraries across the North Western Province participated in the programme. The success of this workshop marked a significant step toward fully leveraging the potential of Koha in public library systems. The event was coordinated by Ms. Priyantha Rathnayaka, Chief Librarian of the Kurunegala Public Library.
- Discussion with the Chief secretary of Southern province regarding some professional issues in Public Libraries on 27th March 2025. A one-day workshop on “The Usage of AI in the Cataloguing Process in Public Libraries” was organized by the Public Library Group and held on 21st March 2025 at the Gampaha Public Library. The programme was facilitated by Professor Ruwan Gamage from the National Institute of Library and Information Science, University of Colombo. A total of 30 public librarians participated in the workshop, and certificates were issued by the Sri Lanka Library Association to all attendees. The event was funded by the Gampaha Municipal Council and was coordinated by Ms. Aravindi Gajanayaka, Librarian of Gampaha Public Library. This workshop was instrumental in enhancing the skills and knowledge of public librarians, particularly in integrating AI tools into cataloguing processes, thereby improving the overall efficiency of public library services.

- A seminar on “Responsibilities, Developing Attitudes, and New Trends in the Public Library Profession” was held on 2nd April 2025 at the Akmeemana Divisional Secretariat Auditorium in Galle. A total of 85 public library professionals from the Southern Province participated in the programme. The resource person for the session was Dr. R. D. Ananda Tissa, former President of the Sri Lanka Library Association. The programme was coordinated by Ms. Wijayanthi Wijesinghe, Librarian of Akmeemana Public Library. Through this seminar, participants gained valuable knowledge about their professional responsibilities, strategies for developing positive professional attitudes, and insights into emerging trends in the public library profession.

6.10 School Libraries Group

The School Library group set out with a clear mission: to promote best practices in school library services, foster a vibrant reading culture among students, and elevate the role of school libraries in Sri Lanka’s educational landscape. Central to this vision was the implementation of programmes that encouraged innovation, professional development, and policy dialogue. A key initiative the Best Practice Competition served as a platform for librarians to showcase effective and creative strategies for utilizing school libraries to improve reading habits and student engagement. Through nationwide collaboration, training, and recognition, the group aimed to build a sustainable culture that values libraries as essential hubs of learning and literacy.

The group conducted seven significant programmes that contributed to the professional development of school librarians, improved library infrastructure, and strengthened advocacy efforts for the recognition of school libraries in Sri Lanka. These programmes spanning training, dialogue, and competitions had a notable impact on library services across the country.

6.10.1 WhatsApp Group

The Sri Lanka Library Association School Library Group 2024/2025 has initiated the creation of WhatsApp groups to strengthen communication and collaboration among school library staff across the country. This initiative includes one main group encompassing school librarians island-wide, along with nine additional groups representing each of the nine provinces. All groups consist of nearly 350 members, ensuring broad representation and active engagement. These platforms aim to promote effective information sharing, foster professional networking, and support coordinated efforts for the development and advancement of school libraries throughout Sri Lanka.

6.10.2 Best Practice Competition 2025 – Launch a National Campaign

This initiative was launched at the National Education Institute Auditorium in 16th September 2024 and was subsequently promoted at the national level. It encouraged school librarians to submit innovative best practices. A large number of schools participated, submitting comprehensive reports and paying an entry fee. All participants received certificates, while four winning schools were awarded Rs. 10,000 book vouchers, trophies, and certificates (for both the librarian and the school). The initiative received generous community support.

6.10.4 School Library Staff Empowerment Programme – Kandana (16th October 2024)

Organized in collaboration with the Negombo Zonal Education Office at De Mazenod College, this event empowered 34 school library professionals. Sessions led by Mr. Sarath Nanda Kumara and Dr. (Ms.) K.R.N. Harshani focused on library management and activity-based services. Mrs. D.R. Chandima Dissanayake also presented an overview of the Best Practice Competition. The event was praised by Ms. Gayani Perera, Deputy Director of Education.

6.10.5 Seminar on Modern Library Management – Galle (19th November 2024)

A seminar held at St. Aloysius' College and trained 82 library professionals in key areas such as inventory management, disposal procedures, documentation, and innovation. The resource persons for the programme were Mr. Sarath Nanda Kumara, Dr. (Ms.) K. R. N. Harshani,

and Ms. D. R. Chandima Dissanayake. Participant feedback emphasized the practicality and relevance of the training, highlighting its value in enhancing day-to-day library operations.

6.10.6 Discussion with the Ministry of Education – Colombo (28th January 2025)

A high-level discussion was convened to address challenges in the school library sector and propose long-term policy improvements. The session brought together key stakeholders, including the leadership of the SLLA, Dr. Preethi Liyanage, Dr. (Ms.) C. K. Gamage, Mr. Sugath Gunathilaka, and Ms. D.R. Chandima Dissanayake along with representatives from Library and Information Science institutions and officials from the Ministry of Education. This collaborative dialogue laid a strong foundation for more effective and sustained policy development in support of school libraries.

6.10.7 Online Discussion on Problems in School Library Posts – (7th April 2025)

Attended by 117 library staff members, this online event provided valuable insights from leading professionals. Speakers included Senior Prof. W.A. Weerasooriya, Prof. Ruwan Gamage, Mr. Uditha Alahakoon, Mr. Mihira Aravinda, and Mr. Padmasiri Thenabadu (former Director of School Library Development, Ministry of Education). The session was highly appreciated for its practical relevance and forward-thinking approach.

6.10.8 Data Collection for Staff Post Analysis

Conducted via Google Forms, this data collection drive gathered extensive information on current school library staffing. The collected data is currently under analysis and will support advocacy efforts to resolve long-standing staffing issues and propose effective solutions. This initiative was led by Prof. Ruwan Gamage and Ms. D.R. Chandima Dissanayake.

6.11 National and Provincial Libraries Group

The National Library and Provincial Libraries Group conducted two capacity-building programmes to equip library professionals with emerging technologies in library and information science. The first programme focused on exploring conservation and preservation issues in the region. The second programme aimed to raise awareness about legal deposit protocols, with the objective of empowering the library profession.

6.11.1 Panel Discussion: Preservation Strategies for Library Materials in Tropical Climates

A panel discussion titled “Preservation Strategies for Library Materials in Tropical Climates” was organized by the National Library and the Provincial Libraries Group on 8th November 2024, from 11.00 am to 1.00 pm, as an online programme.

In Sri Lanka’s tropical climate, museum libraries and archival collections face unique challenges, particularly from pest infestations. Warm temperatures, high humidity, and abundant organic materials create ideal conditions for pests such as silverfish, cockroaches, beetles, and termites, all of which pose significant threats to fragile archival materials.

- Resource persons from national libraries in tropical regions shared their expertise during the discussion.
- Dr. Udaya Cabral, Deputy Director (Conservation), represented the National Library of Sri Lanka.
- Ms. Majidha Ali, Deputy Librarian, represented the National Library of the Maldives.
- Ms. Leni Sudiarti, Conservator, represented the National Library of Indonesia.
- Dr. Patricia Engel, from the Centre for the Protection of Cultural Property at the University of Krems, Austria, served as the keynote speaker.

The panel discussion was attended by around 70 participants, including representatives from Vietnam, the United Kingdom, Canada, Pakistan, and India. The event concluded with a fruitful exchange of ideas, as participants shared and learned about various pest control and preservation strategies used in countries with similar climatic conditions. These insights were valuable in improving future preservation efforts.

6.11.2 Webinar: Present Practice of Legal Deposit Law in Sri Lanka

A webinar on the current practice of legal deposit law in Sri Lanka was conducted by Ms. Chamila Priyangani, Assistant Director of the Department of National Archives. It was held online on 28th March 2025, from 10.00 am to 12.30 pm. Ms. Chamila Priyangani explained the present implementation of the archival deposit law and highlighted challenges faced by professionals in fulfilling their duties. Participants emphasized the need for new and updated legislation to address issues in the digital age, underlining the urgency of amending the legal deposit law in the near future.

The legal deposit law is governed by the Department of National Archives, and it was shared during the webinar that the authorities are currently in the process of amending the law a welcome development for the participants. Attendees expressed interest in contributing to the amendment process and requested the opportunity to submit their concerns to the relevant committee. A total of 71 participants attended the programme.

6.12 Government Libraries Group

On 6th June 2025, the Government Library Group successfully conducted an online workshop focused on the integration of Artificial Intelligence (AI) in government libraries. The session, held via an online platform from 8.00 p.m. to 9.30 p.m. was led by Mr. P.P. Wadanamby, an ICT Officer from the Department of Census and Statistics. The workshop covered key aspects of AI applications relevant to government libraries, enhancing participants' understanding of emerging technologies and their practical implications in library services. The event was attended by 42 participants, reflecting strong interest and engagement from the government library sector.

6.13 Office Management and Finance Committee

Recent developments in staffing have strengthened the Association's operational and administrative capacities.

In line with our commitment to enhancing educational programmes and support services, the Council has approved the extension of the appointment of a Management Assistant – Education on a one-year contract basis. This position will play a key role in coordinating educational activities, liaising with academic institutions, and supporting the development and delivery of training programmes.

To improve administrative efficiency and provide essential clerical support, the SLLA has also appointed an Office Assistant on a one-year contract. This role will assist with day-to-day office operations, correspondence, and general administrative duties.

Recognizing the importance of financial management and accountability, SLLA has confirmed the position of Management Assistant (Finance) as a permanent staff role. This appointment ensures continuity and expertise in managing the Association's financial affairs, budgeting, and reporting.


